The 640i and 780i Insertion and In-line Thermal Mass Flowmeters are used for gas flow measurement applications. The flowmeters integrate configuration, validation and diagnostics in a probe-mounted or remotely mounted housing. When remotely mounted, the electronics enclosure can be mounted up to 200 feet away from the remote probe enclosure. All variables can be monitored on an optional, viewable display. The flowmeters can also provide 4-20 mA flow and temperature output, alarm output and an optional pressure output.
